

Privacy Policy

WP Haton welcomes you to this website and appreciates your interest in our company and our products and services. WP Haton values great importance to your privacy. We therefore feel it is important to inform you about how we handle your personal data.

General

This Privacy Policy applies to all personal data that visitors to the WP Haton website (hereinafter: 'website') leave. During a visit on our website, you may be asked to provide your personal information. It is your choice to do this or not to do so. When you leave your information on the website, you are implicitly agreeing to this privacy policy.

Processing of personal data

Data that you provide via the website to WP Haton is processed by us for general business purposes. When requesting or specifying information via the website we ask for information such as name, contact details, etc. We expect you to provide us with correct information. WP Haton processes these personal data exclusively in accordance with the General Data Protection Regulation (GDPR).

Retention of data

WP Haton only saves and uses data that are specified directly to WP Haton for which is clearly stated at the point that these are provided to WP Haton.

WP Haton does not keep your data any longer than is strictly necessary. WP Haton may retain anonymous data for statistical and research purposes. WP Haton has introduced the necessary security measures to prevent the loss, unauthorized use or modification of any information provided by you.

Upon each visit to the website, your (fixed or temporary) IP address is detected and, if possible, the website of origin. WP Haton does not keep and use this information as individual (personal) data, but only to analyse the navigation and pages visited to improve the awareness, functionality, and content of the website.

Use by third parties

WP Haton will not provide your personal data to third parties, unless:

- You have given your explicit consent to do so.
- It is necessary in connection with an agreement established between you and WP Haton.
- It is necessary to take certain pre-contractual measures in connection with a request you have made, where such measures are required to conclude an agreement. This includes application for a job at WP Haton.
- WP Haton is compelled to cooperate in a valid legal process, such as the serving or receiving of a subpoena, complying with a request of the courts, or initiating legal proceedings.
- WP Haton believe you have done something that conflicts with the terms of use of the website.

Cookies

To enhance the provided service, the website may place 'cookies' on your computer. These are small data files that are stored on your computer. The cookies are used for purposes such as keeping track of the interaction with visitors to the website. In connection with this, we use the Google Analytics program, a web analytics service from Google Inc.

The regulation of cookies through your browser does not affect the use of the website, but it may affect your use of other websites.
